General:

The office continues to run smoothly. No significant problems have been encountered since the June meeting.

NPGA Coordinators:

As of the writing of this report, no reports have been received from the Show Coordinator, ROA Coordinator, or Affiliated Clubs Coordinator. The Election Coordinator report has been received and reviewed.

The coordinators have been reminded to complete a policies and procedures document to be submitted to me as soon as possible. A policy and procedures document for the election coordinator has been received.

Membership and Processing

The drop off in membership continues. We only received 356 new members in 2009 which is a decline of 56 members from last year or 14%. Membership seems to be fairly evenly distributed across the regions with the following breakdown.

I am waiting for final approval by the board on the color chart and color description before I contract with Donna Kohler to do the programming work to include the MC on the registration Certificate. I will have all programming needed done at one time to save some charges. At this time I have not received any requests for a MC designation on the registration certificate from any of the winners of this title. I expect that I may be able to have this accomplished by the June meeting.

Policies and Procedures

I have a few policies and procedures finished and will provide them as attachments. There are still some to be written, but I will submit them as they are finished. I realize that some issues on the board agenda may change some of the policies and or procedures as they are outlined here, but this is a starting point.

Equipment update:

Once again Pitney Bowes has required that I update our mailing machine. The machine they supplied a year or so ago is no longer supported by them and they required that I update the equipment. The machine I now have should be good for a few years! This machine is a bit more expensive to lease, but it includes all postage updates and postage refills at no charge. Previously we were paying an annual fee for "insurance" to update any postage increases and were also charged a fee each time the postage was refilled in the machine. We should actually be in a better position with this machine and should incur less costs.

2010 Roster:
